The NPS "Museum Handbook," Part I (Rev 9/90), Chapter 4, recommends that temperatures not exceed 24°C (75°F) and relative humidity (RH) not rise above 65%. These conditions are maximum levels and only reduce the potential for microorganism growth. They do not eliminate the threat.
